### Water-based pigments

**Arcocem® WT Plus are the individual doses of pigments that allow us to obtain the Topciment® colour charts. Suitable for water-based systems.**

**34 colours for Standard, Unlimited and Evolution microcement systems; 16 colours for Efectto Quartz; 2 colours for Atlantic; and 16 colours for Industrial.**

**24 colours for the Stonecem® Texture, Covercem® Monocrom, Covercem® Restaura and Covercem® Stone stamped concrete systems.**

#### Characteristics

- Easily miscible.
- Water-based, non-flammable.
- Free of plasticisers, solvents, ammonia and emulsifiers.
- High colour stability. Pigments suitable for outdoor applications.
- Alkali resistant.

#### Application

To obtain the colours in the Topciment® catalogue, the dosage indicated by the manufacturer must be respected. Both for the quantity and for the type of system used and sealer.

Pigments compatible with Standard, Unlimited, Evolution, Atlantic and Efectto Quartz microcement systems.

1. Homogenise Arcozem® WT Plus until a homogeneous liquid is obtained.
2. Add the Arcozem® resin and mix with mechanical agitation at low speed.
3. Gradually add the powder until the viscosity required for each application and a homogeneous colour is achieved. In the case of Efectto, add the product directly and homogenise.

They are also suitable for Industrial, our epoxy microcement.

Add Arcozem® WT Plus to component A, component B is not pigmentable. Previously, component A has been mixed with Epoxy 100 Accelerator.

#### Stamped concrete application

Arcocem® WT Plus pigments can also be used in Stonecem® Texture, Covercem® Monocrom, Covercem® Restaura and Covercem® Stone stamped concrete systems.

#### Consumption

Depending on the colour of the dose to prepare.

## Special precautions

To prevent the product from drying out or thickening, close the lid after each use.  
Non-toxic, non-hazardous and non-flammable under normal handling conditions.  
This product does not contain any harmful substances that would require, under current regulations, any additional labelling measures.

In case of contact with skin, wash with soap and water.  
Never use solvents or thinners. Do not swallow. In case of ingestion do not induce vomiting and seek medical attention immediately.
